There will be WRDX, WD and WRD testing in that order on Saturday & Sunday. The Entries are limited to 25 dogs each test day with a minimum of 5 entries. 5 of the 25 entries are reserved for WRDX entries. If there are not 5 WRDX entries the remainder of the entries will be filled with WD and WRD entrants.

Entries from within the United States will be accepted by US Postal Service mail only and priority will be given to entrants who have not earned titles in the division entered.

**ENTRIES FROM NON-MEMBERS OF THE NEWFOUNDLAND CLUB OF AMERICA WILL BE ACCEPTED WITH POSTMARKS AUGUST 2, 2019 OR LATER**

**ENTRIES WILL NOT BE ACCEPTED IF POSTMARKED PRIOR TO THESE DATES.**

**ENTRIES RECEIVED AFTER THE ENTRY LIMIT HAS BEEN REACHED AND BEFORE THE CLOSING DATE WILL BE PLACED ON AN ALTERNATE LIST IN ORDER OF POSTMARK. 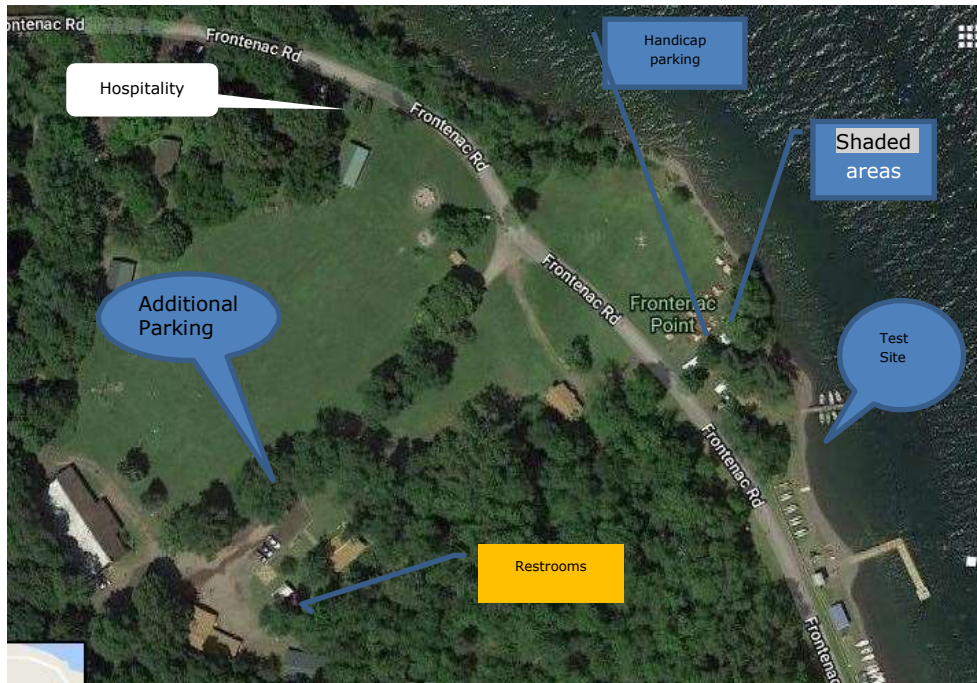

### **Brown Bag Auction**

We will have a brown bag raffle and silent auction at the Hospitality pavilion. Your donations are always welcome and appreciated.

**Test Site:** The Water Test is at Camp Barton on the West Shores of Cayuga Lake. The site consists of a large lake with a soft shale beach which continues into the water beyond swimming depth. The average Newfoundland is swimming about 20 feet from the shoreline dependent upon seasonal water level. Wind and wave action can result in choppy water. There is ample shade and parking with a nice view of the test site. Restrooms include a porta john just off the beach, a running water facility is available marked on map below. Hospitality is North West 500 feet of the test site in a pavilion. There is parking 550 feet west of test site. You will be able to unload your crates at the site, and some handicap parking is available. **Please notify the TEST Secretary what provisions you will need.** All others will park near the restrooms and walk down to the test site. There is a shaded lawn next to the Site where you can set up crates. A Safety Officer shall be notified on the locations of all dogs attending the event!



### **\*\*\* NCA Dog Aggression Policy \*\*\***

The WDC and the NCA have adopted the AKC official policy concerning dog attacks that lead to an injury, either to a person or to another dog. Judges may excuse, and even ask to have removed from a test site, if necessary, any dog that appears dangerous to other dogs or persons.

"Any dog that in the opinion of the Event Committee, attacks a person or a dog at an NCA working event, resulting in an injury, and is believed by that Event Committee to present a hazard to persons or other dogs, shall be disqualified. When the dog is disqualified by the Event Committee pursuant to this section, a report shall be filed with the NCA Board. The disqualified dog may not again compete at any NCA working event, nor be on the grounds of an NCA working event unless and until, following application for reinstatement by the owner to the NCA Board, the owner receives official notification in writing from the NCA Board that the dog's eligibility has been reinstated."

### **Bitches in Season**

Bitches in season will not be allowed on the test site until just prior to being judged, which will be after all other dogs are tested. When not being tested, bitches in season must be contained in a designated area away from the official test areas. If you are entering a bitch, do you anticipate she might be in season? As a courtesy, please inform the Test Secretary prior to the test.

### **Spectators and Non-entered Dogs**

Spectators as well as non-entered dogs (**except bitches in season**) are welcome at the GRNC Water Test. As a courtesy to our exhibitors, we ask that all dogs be kept quiet and leashed or crated. The Safety Office shall be notified of all locations of all dogs attending this event.

### **Safety Observances**

Dogs must be crated or on leash at all times.

When on leash, the length of the leash must not exceed SIX feet and may NOT be a retractable leash.

When on leash dogs must be under control at all times.

Dogs showing uncontrolled or aggressive behavior will be asked by the event chair, a board member, Safety officer or other official to leave the site promptly or be crated for the duration of the test.

Anyone entering or attending this test agrees that the test committee has the right to remove using whatever means is necessary any animal from any vehicle or other containment that in their opinion is in distress.

**East/West on I-90 NY State Thruway**—Take the RT 414 S **Exit 41** toward Waterloo/Clyde Waterloo/Seneca Falls. In .8 miles merge onto NY 414 South / Ridge Rd. In .3 miles turn left on NY 318. In 4.1 miles turn left onto US-20 E. In 446 feet Turn right at the 1<sup>st</sup> cross street onto NY-89 South In 30.5 Miles Turn Left onto Frontenac Road in 0.6 miles your Destination will be on the Right.
